The "Train a Dog-Save a Warrior (TADSAW) program accomplishes this byhaving the Veterans participate in the positive reinforced training techniques from start to finish with the Service Dog candidate, thereby establishing and strengthening the canine-human bond, which is so necessary for any working dog team. The TADSAW philosoph "Together you train to hone your skills and BOND as a TEAM. In 2018, TADSAW INC provided 1559 applications, recieved 654 completed applications ready to start training and ACCREDITED 149. Service Dog Teams, including 16 Vietnam Veteran and ONE Korean War Veteran and 9 TADSAF (Train a Dog Save a Family member program) Service Dog Teams. The ratio of Teams is 97 MALE (Men) to 52 (Women) Veterans From July 2010 thur December 31, 2018., TADSAW INC has provided 12037 applications to Veterans, recieved 4989 "completed applications ready to start trainin" and ACCREDITED 770 Service Dog Teams, including 170 Vietnam Veteran and One Korean War Teteran and 48 TADSAF Service Dog Teams. There are 697 Male Veterans and 253 Female Veterans comprising the Service Dog Teams.

This figure increases to 19.04% when based upon the number of "completed/ready to start training" applications is employed in the calculation. A Texas State University Masters Thesis, published in 2014, utilizing and measuring the resultsof 154 TADSAW Service Dog Teams participating, indicated a 22.9% decreases in the severity of PTSD symtons measured from prior to the start of Service Dog Training, and re-evaluated at the conclusion of training when the TADSAW Public Access Temperament Test (PATT) is successfully completed.
